Qualification & Experience: (a) Graduate from recognized University.
(b) Working knowledge of Computer Office works
(c) Knowledge of Manipuri, English & Hindi.

Age: Maximum age limit shall be 38 years and minimum age shall be 18 years as on 24.04.2026. Maximum age limit is relaxable by 5 (five) years in case of candidates belonging to Schedule Castes/Schedule Tribes and by 3 (three) years in case of candidates belonging to the Other Backward Classes.

Date of Examination Test/Interview - Date will be notified in the official website of the Manipur Judicial Academy.

- ★ Filled up application form has to be submitted physically to the office of the Manipur Judicial Academy on or before 22.04.2026.

Scheme of Examination:

- Multiple choice objective type examination of 3 hours duration:
 - (a) English Language -- 40 marks
 - (b) General awareness -- 30 marks
 - (c) Quantitative aptitude -- 30 marks

Candidates in the ratio of 5:1 of the total number of vacancies will be shortlisted on the basis of merit in the written examination to appear for the computer typing test.

- Computer typing test -- 20 marks
 - (a) The computer typing test for 5 minutes will be conducted for those candidates who are shortlisted in the written examination.
 - (b) Minimum typing speed. --35 w.p.m
- Viva voce/interview -- 30 marks

Only those candidates who qualify in the computer typing test will be called for Viva-voce/Interview.
